3. Statement of Account and Balance Sheet

The outgoing Treasurer Pat Blashill circulated a Treasurer's report (see separate report). The club received an income of £4,874, had expenses of £4,796.01, and has a net balance of £50.99.

4. Amendments to the Constitution and Club Policies

A motion to amend clause 8 (Management) clause 8(a), adding two positions of General Committee Members to the Committee. The motion was put to the membership and approved unanimously.

5. Hosting an Edinburgh Frontrunners Pride Run in June 2026

A motion to host an Edinburgh Frontrunners Pride Run was put to the membership and approved unanimously. A custom-made mug was gifted to Neil Laidlaw as appreciation for his effort in leading the organisation of Edinburgh

Frontrunners Pride Rune in 2025. Neil has also agreed to lead the organisation in 2026.

6. Setting up an EFR Access Fund

A motion to set up an EFR Access Fund to meet the entrance fees of runners experiencing financial hardship was put to the membership and approved unanimously.

7. Approval of the Annual Membership Fee

A motion to keep the club membership fees at their current level of £15 for regular members and £5 for students/unwaged for the 2025/26 was put to the membership and approved unanimously.

8. Prize Nominations

- Biggest contribution to EFR culture in 2025, and
- Committee member of the year.
